## Facilities Use Application – Policy on Alcohol & Waiver

This attachment is required for all organizations or groups, including individual church members and church organizations which are submitting an Application for Use of Facilities and wish a waiver of the "Alcohol Prohibited" policy. Please read the following policy on alcohol and sign where indicated. The Holy Cross Lutheran Church Council, hereinafter referred to as the Council, reserves the right to restrict the serving of alcohol on its premises.

All persons, organizations and groups that are requesting a waiver to permit the serving of alcohol at a specific event must agree to abide by the following rules and regulations:

The undersigned will accept personal responsibility for the serving of alcohol products, including but not limited to: beer, wine, distilled spirits, wine coolers and flavored malt beverages. Holy Cross Lutheran Church of Ronkonkoma, NY hereinafter referred to as Holy Cross, will accept NO responsibility with regard to the serving of alcohol products.

No alcohol products may be consumed outside of the facility. This includes parking lots, ground, sidewalks, streets, etc.

No person under the age of 21 years old may be served or may consume alcohol anywhere in Holy Cross' buildings or on its grounds. The undersigned accepts all responsibility for any liabilities, claims or legal actions that arise out of a person under 21 years old consuming alcohol. Further, the undersigned, agrees to pay any damages, court and legal fees, with regard to any liabilities, claims or legal actions taken against Holy Cross due to violation of this rule.

No alcohol products may be sold for off premises consumption.

The undersigned agrees that all empty containers will be removed from the church property when the event is over.

The undersigned, and any group or organization they represent in applying for use of the facilities, agrees to insure the safety of all those who consume alcohol at its event. This includes that the undersigned will assure that those participants whose abilities are impaired, as defined by The State of New York definition of impairment and intoxication, as well as, those whose who exceed the blood alcohol limit, as defined by The State of New York, will provide safe transportation home. The organization, group and the undersigned agree that Holy Cross will not be liable for any claims, accidents, injuries or deaths regarding participant's actions. The organization, group and the undersigned agree to be responsible for any and all claims, accidents, injuries, deaths, and court and legal fees arising out of failure to comply with this rule.

This agreement is executed in the County of Suffolk, in the State of New York and is governed by the laws therein.
